### 4. Finance Report

• Summary assessment of accounts for each department:

4.1 Operations –Income is above budget for the month by almost 30K and YTD also by over 30K due to \$20,000 unbudgeted income invoiced to RA for SIRR. Regatta income is in line for both clubs and RNSW regattas .Both the Schoolboy and Schoolgirl Head of the river successfully running in line with budget. The King's Cup lunch was a great day, enjoyed by all and made a profit of over 3K.

Equipment Hire is also running ahead of budget by over 10K YTD with the catamarans being utilised by Rowing Australia, Canoe Australia and several larger regattas at SIRC including AAGPS.

Operations expenses are in line for the month and slightly behind year to date by 20K. Only line in Operations expenses above budget is regatta secretary wages as a result of final payout. All in all operations is ahead in income and behind in expenses YTD.

4.2 Development–Income for the month relates to Steptoe Trust \$5000 donation toward the RNSW state team, otherwise no revenue for development in March due to State team activities. Income is slightly behind budget for the year .Development Expenses for the month comprises mainly State Team expenses, including kit and state team dinner. Development expenses are slightly behind budget for the month and in line budget YTD.

4.3 Administration –Income for the reporting period is above budget for the month and year to date. In March we received sponsorship income from Designer Paintworks and Pontoon Sports. With Designer Paintworks increasing their sponsorship commitment by 30%. Membership income is in line with budget for the month and slightly above budget YTD due to the AAGPS membership category not being included in the budget. Administration expenses are above budget for the month due to unforeseen expenses associated with the office relocation.

4.4 At this stage of the financial year we are sitting at 14K above budget. We had a busy and yet highly successful March ran 2 large regattas and 1 main event. We also increased hit milestone on facebook by hitting 4000 like after successfully engaging the schools in a facebook end of season school video competition.
